# SECTION 1: BACKGROUND

Ahmedabad Municipal Corporation (AMC) is the principal urban local body responsible for municipal governance, infrastructure development and delivery of civic services in Ahmedabad. AMC performs key civic functions including urban planning, water supply, transportation, public health, waste management and procurement of works and services. AMC has consistently adopted technology-driven initiatives to improve transparency, accountability and operational efficiency across its departments.

Smart City Ahmedabad Development Limited (SCADL) is the Special Purpose Vehicle constituted under the Smart Cities Mission to plan, develop and operate smart urban solutions for the city of Ahmedabad. As the nodal agency for technology-driven urban governance, SCADL has implemented major digital initiatives such as the Integrated Command and Control Centre (ICCC), citywide surveillance systems, emergency response platforms, smart mobility solutions, sensor-based environmental monitoring, integrated data management frameworks, e-challan systems and various e-governance initiatives. SCADL is also designing and implementing AI/ML-enabled use cases for data analysis and predictive insights using data collected through smart city cameras, IoT devices and sensors.

SCADL is responsible for strengthening institutional data flows across municipal departments and building city-level intelligence systems that support real-time monitoring and data-driven decision-making. For this, SCADL is establishing the Ahmedabad Urban Observatory, a citywide analytical framework designed to aggregate departmental datasets, generate operational insights through predictive analytics and support evidence-based decision making for municipal leadership.

In line with AMC's and SCADL's broader digital transformation agenda, there is a growing need to extend similar levels of automation, standardization and intelligence to core administrative functions, including tender management.

## 1.1. Existing Scenario

Despite significant progress in digital governance and data-driven systems, the tender creation and evaluation process within AMC remains largely manual and document-intensive. AMC processes an average of approximately 1,500 to 2,000 tenders annually across departments of engineering, planning and maintenance works. This high volume of tenders requires frequent drafting, publication, evaluation and award activities.

The current process involves repetitive drafting, manual compliance verification, multi-level approvals and time-consuming bid assessments. The lack of automation leads to longer turnaround times, inconsistencies across departments, higher dependency on manual effort and increased risk of errors. These challenges highlight the need for a technology-enabled, standardized and intelligent procurement solution that aligns with AMC's and SCADL's overall vision for transparent, efficient and data-driven governance.

## 1.2. Objectives

The objective of this EOI for “AI-Based Tender Creation and Evaluation Tool” is to design, develop, implement and maintain an intelligent, end-to-end digital platform that streamlines tender creation, bid submission, evaluation and award processes for AMC, while ensuring transparency, compliance and operational efficiency.

1. To enable standardized and automated tender creation using approved templates, BOQs and clauses, ensuring accuracy, consistency and compliance.
2. To provide an automated pre-bid clarification mechanism that allows agency queries to be submitted, tracked and responded to in a structured and timely manner, ensuring consistent and transparent communication with all agencies.
3. To implement automated evaluation mechanisms that assess agency responses based on predefined evaluation criteria.
4. To support the award process through defined approval workflows and automatic generation of purchase orders and contract documents.
5. To design a scalable, secure and high-performance system capable of handling large volumes of tenders and agency submissions with consistent accuracy and minimal manual oversight.
6. To achieve cost and resource optimization by reducing dependency on manual evaluations and external consultants, leading to process efficiency and long-term financial savings for AMC.
7. To ensure auditability and traceability in all AI-assisted processes to support transparency and accountability in public procurement.

For all kinds of data gathering & EOI submission criteria, the Agencies must follow following matrix.

### **1.3. Purpose of EOI**

The purpose of this Expression of Interest (EOI) is to invite eligible and experienced agencies to express their interest in the design, development, implementation, and maintenance of an AI-Based Tender Creation and Evaluation Tool for Ahmedabad Municipal Corporation. Through this EOI, Smart City Ahmedabad Development Limited aims to identify technically qualified and financially capable agencies with relevant experience in AI/ML-based solutions and tender management systems. This process will help SCADL assess market capabilities, understand available solutions, and shortlist suitable agencies for the subsequent Request for Proposal (RFP) stage.

# **SECTION 2: SCOPE OF WORK**

This section outlines the project description and scope of work for the AI-Based Tender Creation and Evaluation Tool, covering the system's functional modules, project activities and expected deliverables. The proposed platform shall incorporate the following modules:

## **2.1. Tender Generation and Bid Management**

- Enables AMC Departments to generate tenders in authorised format with minimal inputs from the user. The AI tool reference past tenders, reference documents and current requirements to generate tenders in predefined templates in compliance with CVC guidelines.
- A guided digital interface is utilised by the user to input any relevant detail related to items, quantities, delivery schedules, costs etc.
- Supports secure submission of online and offline bids by the agencies with timestamped logging and encrypted commercial bid storage.
- Pre-bid clarifications, corrigenda and meeting of minutes are managed through a version-controlled platform, ensuring transparent communication with all agencies.

## **2.2. Evaluation, Comparative Statement and Award Decisioning**

- Automates the evaluation of bids by generating comparative statements for technical and commercial bids uploaded by the agencies.
- An AI Chatbot answers unstructured queries across all modules by assessing all uploaded documents with responses restricted by role-based access controls.
- Enables the review committees to securely access all bids, records their observations and generates a consolidated award recommendation, ensuring full traceability.

## **2.3. Post-Award Processing, Compliance and Analytics Integration:**

- Synchronises award outputs with AMC's ERP, enabling creation of Purchase/ Work Orders and Purchase Agreements.
- Tracks goods receipts, invoices, and agreement utilisation to recommend on payment milestones.
- Real-time dashboards and KPIs will monitor tender progress, vendor responsiveness, cost variance, savings, contract utilization and compliance with procurement policies. Analytics enable citywide oversight and audit-ready reporting.
